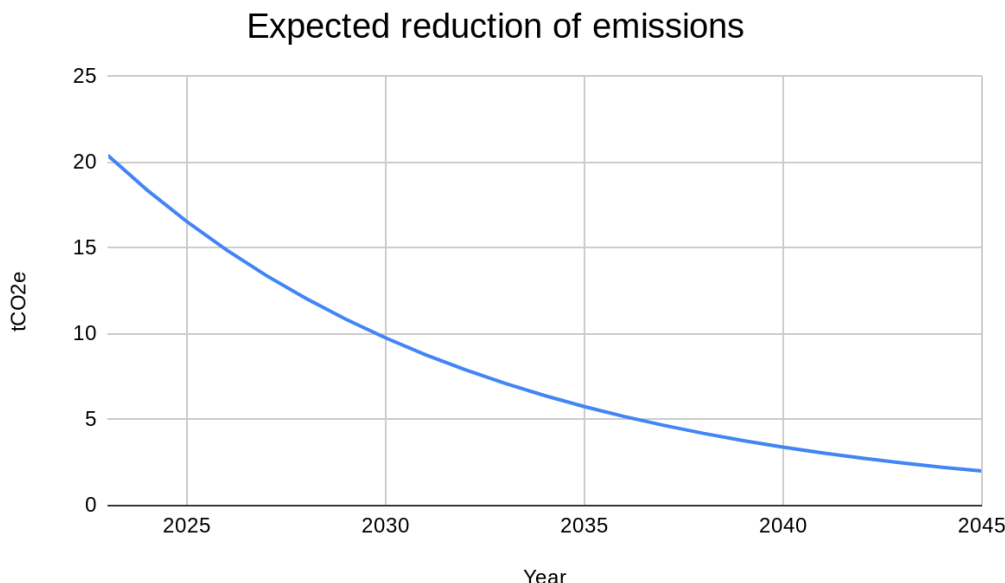

In order to progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 12.05796436 tCO₂e by 2028. This is a reduction of 40%

The following environmental management measures and projects are being implemented to reduce our emissions and meet our targets.

1. As part of our commitment to overall emissions reduction, we are implementing a comprehensive staff education program. This initiative aims to enhance our employees' understanding of how various actions impact the environment. By fostering this awareness, we anticipate a significant decrease in emissions, particularly those associated with commuting and business travel.
2. To mitigate emissions from transportation and distribution, we are initiating dialogues with our supply chain partners. These discussions will focus on identifying and implementing the most environmentally sustainable options available, ensuring that our logistics operations align with best practices in emissions reduction.
3. We are developing and implementing robust sustainable travel and procurement policies. These policies will serve as guiding frameworks to ensure that all business travel and purchasing decisions are in accordance with our emissions reduction commitments.
